

## TECHNICAL SPECIFICATIONS FOR TAP WATER PIPE INSTALLATION AND WATER QUALITY TESTING AT PWEMPHWE COMMUNITY.

This is a contract being signed between Chipembere Community Development Organization (referred herein as the client) and ICON Contractors (referred herein as a company awarded the contract) amount to MWK 525 000 for the installation of tap pipe water pipes at Pwemphwe Community, group village Nkhaka, Traditional Authority Changata, Thyolo district. Southern region of Malawi.

This contract involves working with the community members to dig a pipeline from the river water source (water protected site which is at a distance of 2.5 km) to supply safe and clean water into Pwemphwe community comprising of 6 villages with a total population of 10 967people. The pipelines to pass through six villages where two water collection tanks to be constructed and tap water points properly erected in 12 designated places in all six villages which are: Pwemphwe, Nandolo, Mkhweliwa, Nampira, Kapota II and Kalinda in Group Village Nkhaka, Traditional Authority Changata, Thyolo district.

The contractor shall carry out all works as instructed by the supervisor (organizational officials and community leaders) in a thorough and workman-like manner and up to today's professional standards. The contractor shall carry out operations with due efficiency and dispatch in accordance with the terms of the contract and to the satisfaction of the supervisor.
