
The Internal Revenue Act 2000 makes it clear the category of organisations which fall under the tax-exempt category. Exempt organisations mean a person:

 - ix) An institution or trust of public character established by an enactment solely for the purposes of scientific research; or
 - x) Registered sporting club
- (e) Who or that has been issued with a written ruling by commissioner currently in force.
- (f) None of whose income or assets confers, or may confer a private benefit, other than in pursuit of the organisation's function referred to in paragraph (a).

GRATIS Foundation falls under (a)i and (c) of the Internal Revenue Act 2000, which is in line with the mandate and activities of the Foundation.
