2. DESCRIPTION OF CORE BUSINESS AND IMPLEMENTATION APPROACHES

2.1. Core business

TATEK Universal Supplies is a Malawian company which its core business is processing groundnuts into peanut butter and groundnuts flour. TATEK Universal Supplies is doing its business in Mchinji. Through this business TATEK Universal Supplies gained much experience and that experience was replicated in this project.

3. PROPOSED PROJECT

3.1. Project title: Reduction of aflatoxin in groundnuts

3.2. Project concept

TATEK UNIVERSAL Supplies received a grant from a fabricator who wanted to test groundnuts shelling machine which is a key machine in aflatoxin reduction in groundnuts. Therefore a total of \$180 was granted to TATEK Universal Supplies from the fabricator. TATEK Universal Supplies worked with small holder farmers who produces groundnuts. The farmers from Likasi cooperative were mobilized for testing the machine and were trained by TATEK Universal Supplies. After buying the groundnuts were processed into peanut butter and groundnuts flour,

the products were sold to traders and consumers directly. In this business our main aim was to reduce contamination of aflatoxin in groundnuts.

3.3. Project goal: To reduce contamination of aflatoxin in groundnuts in Msitu EPA in Mchinji.

The project achieved this at the end:

- 1. Increased the average yield of groundnuts produced by smallholder farmers.
- 2. Reduced aflatoxin contamination in groundnuts.
- 3. Helped smallholder farmers to access groundnuts market.

3.10. What made the proposal eligible for financing?

TATEK Universal Supplies is a groundnut processor, not only that small holder farmers were forced to use hands and water to shell groundnuts which was a cause of aflatoxin contamination in groundnuts. Therefore through this project helped the farmers to reverse

the situation sustainably.
